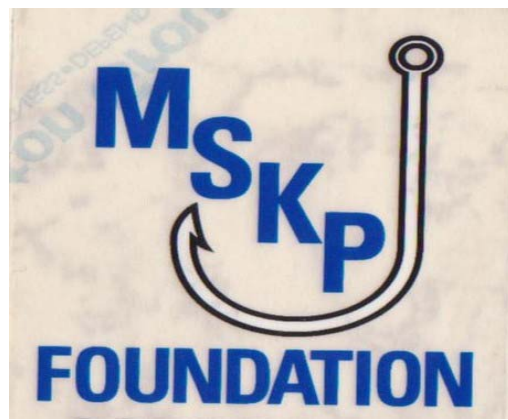

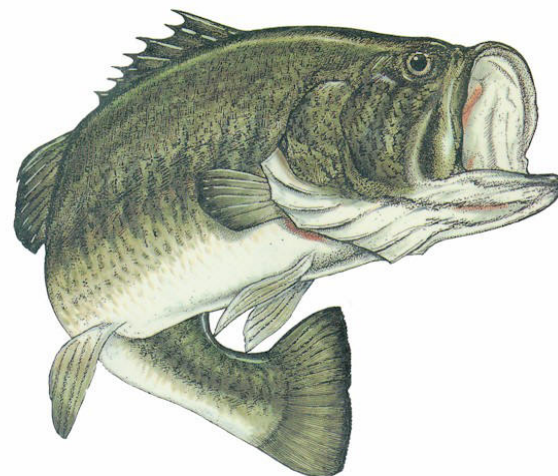

## Tournament Rules

1. Registration will be accepted by mail and on the morning of the tournament.
2. All boats must be equipped with safety equipment as required by law.
3. Life Jackets must be work when outboard is running.
4. Five fish per team.
5. No more than five fish allowed in live well at one time.
6. Only largemouth bass measuring 14" will be weighed (flat board). Short fish will result in loss of that fish in creel.
7. Bass caught while site fishing must be caught in a sporting manner. Hook must be inside of mouth.
8. There will be a 4oz (.25) penalty for dead fish.
9. No cell phones or 2-way radio usage during tournament unless an emergency.
10. Only artificial bait allowed. No chumming or live bait.
11. Selected team members must pass our polygraph test before team is eligible to claim prize money.
12. Live well check will be covered on polygraph.
13. No team may fish within 50 yards of another competitor's boat.
14. Hole sitting by non-competitor to aid tournament participate is not allowed.
15. In case of a tie the winner will be decided by biggest fish in creel.
16. MSKP or its sponsors are not responsible for accidents.
